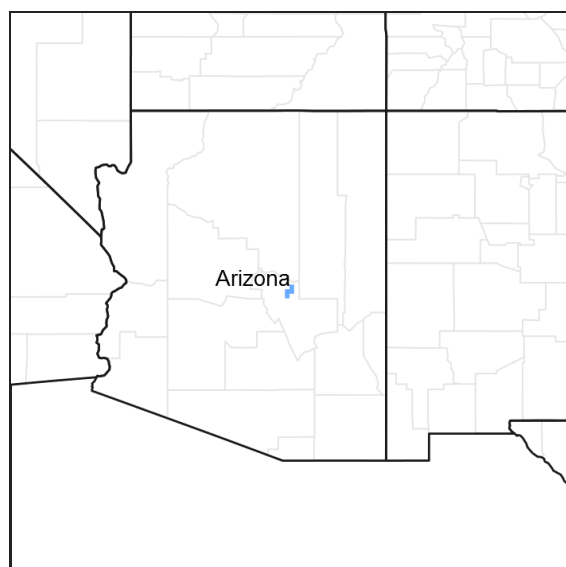


Figure 1. Mapped extent

MLRA notes

Major Land Resource Area (MLRA): 038X–Mogollon Transition South

AZ 38.3 – Upper Mogollon Transition

Elevations range from 5,100 to 7,000 feet and precipitation averages 20 to 27 inches per year. Vegetation includes Gambel oak, Arizona white oak, Emory oak, pinyon, alligator juniper, one seed juniper, Arizona cypress, ponderosa pine, shrubby buckwheat, sacahuista, skunkbush sumac, Wright silktassle, blue grama, sideoats grama, muttongrass, western wheatgrass, and bottlebrush squirreltail. The soil temperature regime is mesic and the soil moisture regime is typic ustic. This MLRA occurs within the Transition Zone Physiographic Province and is characterized by canyons and structural troughs or valleys. Igneous, metamorphic, and sedimentary rock classes occur on rough mountainous terrain in association with less extensive sediment filled valleys exhibiting little integrated drainage.

Ecological site concept

The Granitic Hills ecological site exists on sideslopes with parent material derived from granite.

Climatic features

Precipitation in this common resource area averages approximately 20 to 24 inches annually. Precipitation is lower and temperatures are cooler in the eastern part of the MLRA. The winter-summer rainfall ratio ranges from about 60/40% in the western part of the area to 45/55% in the eastern part. Summer rains fall July through September; and are from high-intensity convective thunderstorms. This moisture originates primarily from the Gulf of Mexico, but can come from the remnants of Pacific hurricanes in September. Winter moisture is frontal, originates in the north Pacific, and falls as rain or snow in widespread storms of low intensity and long duration. Snowfall ranges from 10 to 18 inches per year and can occur from November through April. May and June are the driest months of the year. Humidity is generally low all year.

Average annual air temperatures range from 50 to 57 degrees F (mesic temperature regime). Daytime temps in the summer are commonly in the mid 80's in the eastern portion of the MLRA and the low to mid 90's in the western portion. Freezing temperatures are common from October through April. The actual precipitation, available moisture and temperature varies, depending on, region, elevation, rain shadow effect and aspect.

Ecological dynamics

The plant communities found on an ecological site are naturally variable. Composition and production will vary with yearly conditions, location, aspect, and the natural variability of the soils. The historical climax plant community represents the natural potential plant communities found on relict or relatively undisturbed sites. Other plant communities described here represent plant communities that are known to occur when the site is disturbed by factors such as grazing, fire, or drought.

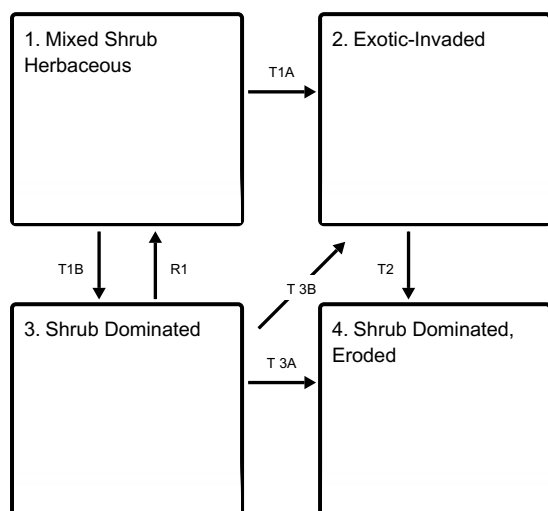
Production data provided in this site description is standardized to air-dry weight at the end of the summer growing season. The plant communities described in this site description are based on near normal rainfall years.

NRCS uses a Similarity Index to compare existing plant communities to the plant communities described here. Similarity Index is determined by comparing the production and composition of a plant community to the production and composition of a plant community described in this site description. To determine Similarity Index, compare the

production (air-dry weight) of each species to that shown in the plant community description. For each species, count no more than the maximum amount shown for the species, and for each group, count no more than the maximum shown for the group. Divide the resulting total by the total normal year production shown in the plant community description. If rainfall has been significantly above or below normal, use the total production shown for above or below normal years. If field data is not collected at the end of the summer growing season, then the field data must be corrected to the end of the year production before comparing it to the site description. The growth curve can be used as a guide for estimating production at the end of the summer growing season.

Mixed Shrub Herbaceous

Exotic-Invaded

Site is dominated by exotic annuals with overall cover at 10-50%

State 3

Shrub Dominated

Shrub density is increased; overall canopy cover is greater than 40%

State 4

Shrub Dominated, Eroded

Shrub Dominated with eroded soils; 10-30% overall canopy cover

Transition T1A

State 1 to 2

Introduced exotics; increased fire frequency.

Transition T1B

State 1 to 3

Decrease fire frequency; continuous season-long grazing; drought.

Transition T2

State 2 to 4

Decrease in vegetation canopy; increase in soil loss; increase in fire frequency; decrease in perennial plants.

Restoration pathway R1

State 3 to 1

Brush Management coupled with grazing management

Transition T 3B

State 3 to 2

Introduction of invasive exotics coupled with a wetter climate.

Transition T 3A

State 3 to 4

Decrease in veg canopy; increase in soil loss; increase in fire frequency, decrease in perennial veg
