Elevations range from 3200 to 5000 feet and precipitation ranges from 12 to 16 inches per year. Vegetation includes mesquite, catclaw acacia, netleaf hackberry, palo verde, false mesquite, range ratany, fourwing saltbush, tarbush, littleleaf sumac, sideoats grama, black grama, plains lovegrass, cane beardgrass, tobosa, vine mesquite, threeawns, Arizona cottontop and bush muhly. The soil temperature regime is thermic and the soil moisture regime is ustic aridic. This unit occurs within the Basin and Range Physiographic Province and is characterized by numerous mountain ranges that rise abruptly from broad, plain-like valleys and basins. Igneous and metamorphic rock classes dominate the mountain ranges and sediments filling the basins represent combinations of fluvial, lacustrine, colluvial and alluvial deposits.

Ecological site concept

Loamy Bottom, Cienega, ecological site is found in bottom positions consisting of water-saturated, poorly drained areas in drainage ways that are intermittently or permanently covered in water. Soils are loamy to clayey with redox features.

Climatic features

Precipitation in this common resource area ranges from 12-16 inches yearly in the eastern part with elevations from 3600-5000 feet, and 13-17 inches in the western part where elevations are 3300-4500 feet. Winter-Summer rainfall ratios are 40-60% in the west and 30-70% in the east. Summer rains fall July-September, originate in the Gulf of Mexico and are convective, usually brief, intense thunderstorms. Cool season moisture tends to be frontal, originates in the Pacific and Gulf of California, and falls in widespread storms with long durarion and low density. Snow rarely lasts more than one day. May and June are the driest months of the year. Humidity is generally very low.

Temperatures are mild. Freezing temperatures are common at night from December-April; however temperatures during the day are frequently above 50 F. Occasionally in December-February, brief 0 F temperatures may be experienced some nights. During June, July and August, some days may exceed 100 F.

Cool season plants start growth in early spring and mature in early summer. Warm season plants take advantage of summer rains and are growing and nutritions July-September. Warm season grasses may remain green throughout the year.

The soil mapped on this unit is in SSA-671 Cochise county Douglas-Tombstone part MU 106 Marsh.

Ecological dynamics

Loamy Bottom, Cienega, ecological site is found in bottom positions consisting of water-saturated, poorly drained areas in drainage ways that are intermittently or permanently covered in water. Soils are loamy to clayey with redox features.

Reference State has two plant community phases reflecting fire interval. The Riparian State (reference plant community) is an open canopy of large, riparian trees (cottonwood, ash, willow or bellota) with highly productive understory comprised of large shrubs (seep willow) and perennial grasses (big sacaton, vine mesquite). Annual

forbs (sunflowers) flourish with rainfall. Tree recruitment is dependent upon weather patterns and sapling maturity upon fire-free interval.

Mesquite, Natives State: Long-term unmanaged grazing depletes the perennial grass component. Mesquite encroach from margins into the Loamy Bottom, Cienega. Continued unmanaged grazing and competition from mesquite reduces perennial grass vigor. Mesquite alter hydrologic functioning of site. Annual forbs will really flourish with the additional bare spaces. Site may occasionally produce and retain enough fine fuels to carry fire. Fire may have the adverse affects of high perennial grass and riparian tree mortality; mequite will resprout within one growing season. Restoration of site can only be done with committed efforts to site and adjacent uplands.

Non-Native State: Non-native trees/shrubs (salt cedar or desert broom) invade the site. Site has closed tree canopy with no understory.

Eroded State: this state occurs if site was historically drained for cultivation or gully erosion occurred. Annual forbs flourish with rainfall.
