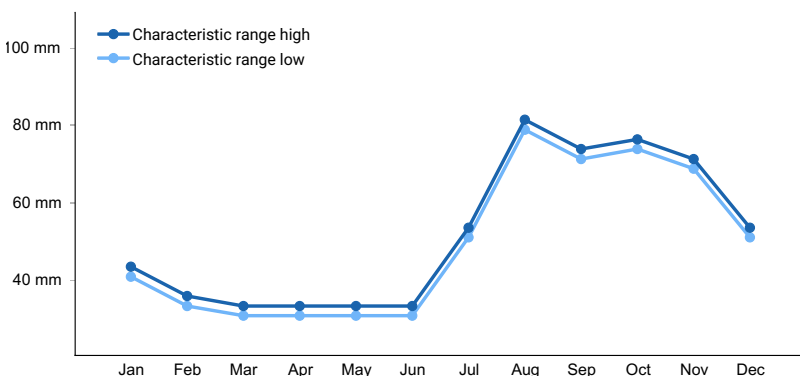


Figure 1. Monthly precipitation range

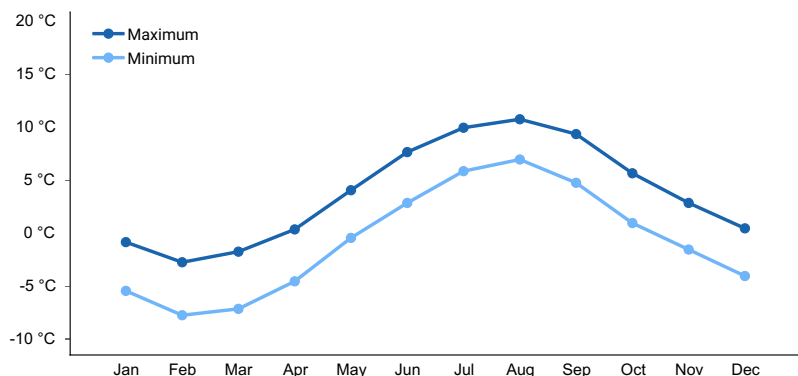


Figure 2. Monthly average minimum and maximum temperature

Willows growing on this site have high forage value and are preferred by reindeer during winter and early spring months. Reindeer will tend to concentrate on this site which is very sensitive to grazing.
